TERMS AND CONDITIONS

- The BTC 2025 Off Peak Season Pass and or Off Peak Discount Ticket are for individual use and are non-transferrable, not shareable, and fees are not refundable other than as stated within these terms and conditions.
- Off Peak Season Pass and Off Peak Discount Ticket are valid from 4/7/2025 through 10/10/2025.
- Holders may play only when the golf course is open for play. BTC Management reserves the right to close the golf course. This may be from weather and any other unforeseen circumstance.
- All Off Peak Season Pass and Discount Ticket holders must check in with the golf shop before play begins.
- BTC reserves the right to block out certain days and or times of the day, due to but not limited to Weather, Maintenance, Tournaments, and/or Outings that may take place on the golf course.
- Off Peak Season Pass and Off Peak Discount Ticket holders agree to abide by all rules and regulations set forth by BTC. BTC reserves the right to suspend or expel any holder, immediately, that fails to follow rules and regulations without written notice.
- Off Peak Season Pass and Off Peak Discount Tickets benefits excludes evening leagues, outing fees, and or any tournament fees. Holders may participate in the above, however must pay full rates.
- Expelled holders shall receive a pro-rated refund to the closest month or partial month of their annual fee, minus \$250.00 administrative fee if the pass or ticket program is sold out, and a replacement ticket holder purchases the ticket. If the pass or tickets are not sold out, the expelled holder shall not receive a refund of any annual fees.
- No show fees apply and shall result in a suspension until paid.

OFF PEAK SEASON PASS:

- Includes golf and cart at no additional cost.
- Off Peak Season Pass holders will be limited to the following Days and Times:
Monday thru Friday: Before 7:30am and 11:00am to 2:00pm
Weekends and Holidays: Any time after 11:30am
(Terms and conditions apply.)

OFF PEAK DISCOUNT TICKET:

- Off Peak Discount Ticket holders will be limited to the following Days and Times:
Monday thru Friday: Before 7:30am and 11:00am to 2:00pm
Weekends and Holidays: Any time after 11:30am
- Ticket holders may play golf at the BTC for a fee of \$15.00 per round. This fee will include the golf and cart and cannot be waived.
- This discount does not include twilight rates, walking rates, 9 hole rates, and cannot be used with coupons, or with any other offers.
- Rainchecks will be issued for a prorated round fee if the round of golf could not be completed due to unplayable weather conditions, injury and or emergencies only.
(Terms and conditions apply.)

TEE TIME POLICY:

- Off Peak Season Pass and Discount Ticket holders shall follow all tee time policies set forth by BTC.
- Off Peak Season Pass and Discount Ticket holders may make tee times 7 days in advance.
- A 24hour cancellation notice will be required.
- Off Peak Season Pass and Discount Ticket holders that fail to appear for reserved tee times, shall be given a warning on the first offense. On the second offense, any holders that fail to appear for reserved tee times, shall be given a week suspension of holder privileges.
